Introduction

'Protecting children from abuse, neglect and exploitation requires multi-agency join up and cooperation at all levels.'

The way in which we work together in Sandwell to ensure the safety of children and young people and support for families at every level across the continuum of help and support is called Multi-Agency Safeguarding Arrangements. These arrangements help to ensure that we are sharing information in the right way, correctly identifying risk and support needs, and that children and families received coordinated and tailored support.


Leadership and accountability

'The purpose of multi-agency safeguarding arrangements is to ensure that, at a local level, organisations and agencies are clear about how they will work together to safeguard children and promote their welfare...there is a clear shared vision for how to improve outcomes for children across all levels of need'

Lead Safeguarding Partners set the strategic direction and vision and foster the culture of local safeguarding arrangements. They are accountable for the effectiveness and outcomes of multiagency safeguarding arrangements.

Delegated Safeguarding Partners deliver on and monitor the multi-agency priorities and procedures to protect and safeguard children and young people. Partner discussions should be facilitated and work completed with the Independent Scrutineer to ensure that procedures work for all partners and that the priorities set in Sandwell are the correct ones.

Independent Scrutiny provides safeguarding partners with independent and effective support and challenge at both a strategic and operational level. This role should drive and support continuous improvements and proved assurance that local arrangements are working for children, families, and professionals.

Working with education providers

The insight and cooperation of all education providers is vital to the delivery of multi-agency safeguarding arrangements. People working in education settings have an important role in relationship building, identifying concerns and supporting children and families. They may be the first trusted adult that the child talks to about their worries.

In Sandwell we have education representation at the Operations group as well as all Subgroups to ensure the voice of those that work closely with our children and young people is heard at all levels. Voluntary, charity, social enterprise and sports cubs

Many of these organisations provide education and activities for children. Staff and volunteers working in these settings will often form good relationships with children and families and play an important role in identifying concerns and offering support. They may be the first trusted adult that the child talks to about their worries.
